First of all, we would like to use this opportunity to wish you all happy holidays and a good start into 2017!

One of our focus working areas for next year and the upcoming period is the integration of a human rights perspective into our project work. But let's begin at the start.

As can be seen right from our logo, World University Service (WUS) Austria is committed to the promotion of the human right to education: Education is a fundamental human right and essential for the exercise of all other human rights. Education is a powerful tool by which economically and socially marginalized adults and children can lift themselves out of poverty and participate fully as citizens.

The **right to higher education** in line with international human rights standards includes the elements of availability, accessibility, acceptability and adaptability which are common to education in all its forms at all levels.

With the recently started E+ project INCLUSION, WUS Austria is partner in a project that **directly** aims at the promotion and realization of the right to higher education by enhancing access to, participation in and successful completion of higher education for persons from underrepresented and marginalized groups (e.g. persons with disabilities, persons from lower socio-economic backgrounds etc.)

In addition, WUS Austria is also committed to apply a human rights based approach in projects which are not primarily aiming at the realization of human rights: This is being done by incorporating and mainstreaming principles of participation, accountability, non-discrimination &

equality, empowerment and legality. These principles can be also summarized by the brief acronym PANEL. They describe the essence of a human rights based approach which is about empowering people to know and claim their rights and increasing the ability and accountability of individuals and institutions who are responsible for respecting, protecting and fulfilling rights. It goes without saying that applying a HRBA does not happen automatically - but requires time and dedicated resources.

We believe though that such an investment is essential, as applying a HRBA has many added values to offer: An HRBA promotes social cohesion, integration and stability; it addresses power inequalities and discrimination, deals with weaknesses in accountability systems and provides an objective framework to manage conflicts and seek redress.

Thematic Article

PATTERNS Lectures awarded course Design and Crisis at the University of Bihać, BiH



What is the role of design in post-industrial society? Can design be an active co-creator of the social and cultural relations in periods of conflicts, depopulation and political tensions? Shall design be exclusively bounded to the industrial sector or can it be part of local and global utopias?

Those and many other questions will serve as a frame for the PATTERNS Lectures awarded course called *Design and Crisis* which will be held at the Textile Department of the University of Bihać in Bosnia and Herzegovina in the summer semester of 2017. By developing awareness for regional design history and taking the point for critical questions on local and cultural context in general, this course pays attention at the inventive and successful design projects in the late socialist period, emphasizing the difficult and unsuccessful transition from an industrial to a crisis shaped environment in Bosnia and Herzegovina and its neighbouring countries. The course will also discuss critical issues in regional design education and questions, how educational institutions can redefine their role in the post-industrial landscape and without substantial industrial support.

The awarded educator and author of the course *Design and Crisis*, art historian Irfan Hošić says that the "main activities of the course will be held outside the Institute. The course will try to initiate collaboration and intersection with a wider spectrum of the public including the local community, artists, designers, architects, cultural activists, etc. Some lectures will be organized in public spaces such as the City Gallery of Bihać or the abandoned textile factory Kombiteks. Many other events will be accompanied and life in the city during March, April and May 2017 will be themed around design, arts and culture."

The development of the course also includes study visits to Ljubljana, Prague, Bratislava, Split, Zagreb and Sarajevo. Also, literature for the Institute's library will be purchased.

For the course implementation, guest lecturers from the USA, UK, Slovenia, Croatia and Bosnia and Herzegovina are invited, which will be a special highlight of the whole project.
